### **About Your Health Care Advance Directive**

A Description of Maine Law on Health Care Advance Directives

#### Choosing your care.

When you need medical care, you have the right to make choices about that care. But there may come a time when you are so sick that you cannot make your choices known. You can stay in charge by putting your choices in writing ahead of this time. This is called giving *advance directives*.

#### What is an advance directive?

Under Maine law, any spoken or written decision or instruction about the health care you want in the future is called an advance directive. You can tell your doctor or family what you want. But it is best to write it down.

Advance directives also are sometimes called *living wills* and *durable health care powers of attorney*. If you have already signed one, be sure your doctor, your hospital and your family have a copy. If you have not signed a form, you may use the health care advance directive available for you in this clinical area. Simply ask your caregiver or care provider for a copy of this form.

#### Who can complete an advance directive?

Anyone living in Maine who is 18 years of age or older can complete an advance directive. If you are younger than 18, you may also be able to complete an advance directive under other certain, limited circumstances.

### How does an advance directive help?

If you sign an advance directive, your family and your doctor will know who to talk to about your care or what kinds of treatment you want or do not want when you are too sick to decide. This could happen if you have a serious illness, are near the end of life, or are no longer aware. If doctors do not know your wishes, they will treat you until they can ask your family what you want. If your family does not know, you may get treatments you do not want or which you would stop if you had your way. In an emergency, you will receive care until the doctors can determine your condition and what your wishes are. If you do not have an advance directive, Maine law allows your doctors to ask your relatives – and perhaps others close to you – to make decisions about your care, as explained below.

#### What do I choose in an advance directive?

Most advance directive forms allow you to do five things:

- 1. Choose someone to make all your health care decisions beginning either right away or when you are too sick to decide. That person is called your *agent*. Your agent can be a family member or friend. If you choose an agent, two (2) witnesses must sign your advance directive.
- 2. Choose whether or not you want certain treatments when you are no longer aware, very ill, or may not live. For example, you can choose what you wish to have done or not done if you are dying, or if you are in a permanent coma. Your agent must follow any choices you make in an advance directive.
- 3. State a desire to donate your organs. (Your family will make the final decision, but this will tell them your wishes.)
- 4. Name your primary doctor.
- 5. State your wishes or name someone to decide funeral and burial matters.

#### What happens if my heart stops in the hospital or nursing home?

If your heart or breathing suddenly stopped in the hospital or nursing home, drugs, machines and other means will be used to try to restart them. This is called *cardiopulmonary resuscitation* or CPR. CPR is always done unless you direct your doctor and the health care team to do otherwise. If you do, your doctor will write an order called a "Do Not Resuscitate" order or DNR. If you have concerns about CPR, discuss them with your doctor while you are well.

# What happens if my heart stops when I am at the hospital for an outpatient visit, getting blood work done or having an XRAY?

In an emergency, you will receive care until the doctors can determine your condition and what your wishes are. This may mean that you might receive CPR until you can be transferred to the Emergency Department and your Medical Record with your advance directive can be obtained. Once your wishes are known, they will be followed.

#### What if my heart stops at home?

If you are at home and your heart stops, ambulance crews may still give you CPR even if you have an advance directive. You should talk with your doctor if you do not want CPR at any time. If you and your doctor have both signed the orange form, then your decision not to have CPR should be followed. Show that form to those close to you and keep it where it will be easily seen. Your doctor will then give you a special bracelet or wallet card designed to alert the ambulance crews that you do not want CPR.

#### When does my advance directive go into effect?

You can fill out the form in either of two ways to decide when it goes into effect. You may want your advance directive to be used only when you are too sick to choose your care or tell others what care you want. If you fill out the form this way, your doctor will decide when the form goes into effect. Or, you may fill out the form so your agent can make those decisions right away, but you will still be told about them.

# If I do not have an agent or an advance directive, who will decide my care when I am too sick to choose?

If you do not name an agent or do not have an advance directive, the doctor will ask your loved ones what treatment you would want, in this order: Your spouse (unless legally separated); someone with whom you share an emotional, physical and financial bond similar to a spouse; your adult children; your parents; your adult brothers and sisters; your adult grandchildren; your adult nieces and nephews; your adult aunts and uncles. If there are family members whom you do NOT want to make decisions for you, you need to put this in writing and give a copy of it to your doctor or hospital.

If the doctor cannot reach a family member, the doctor may ask another adult relative or good friend who knows your wishes or your life values.

### What happens if I do not make an advance directive?

Your family can tell your doctor to continue to treat you. They can also tell your doctor to stop or not give treatment to keep you alive (life sustaining treatment) if you are dying or in a permanent coma. They may also make some other decisions for you if you are no longer aware and there is no guardian or advance directive, but no one may deny surgery or procedures to save your life if your doctor thinks they are necessary.

### Does my doctor have to follow my choices?

Yes. If your doctor, hospital, or other place of health care has any special rules about health care decisions, or if they will not carry out your decisions, they must tell you. They must then arrange to move you to a doctor, hospital, or other place that WILL carry out your decisions.

#### What rights do I have as a patient?

When you need medical care, you have certain rights, including the right to refuse care. You have a right to know:

- What your medical problem is and what tests and treatments may be needed;
- What the doctor thinks can be done and what the usual risks may be;
- If there are other ways to care for you; and
- What may happen if you refuse care.

#### What else should I know?

Every hospital, nursing home and many other places that provide health care in Maine have these forms or can tell you how to get them. If you are hospitalized at Mercy Hospital, just ask your doctor or nurse. They can explain the forms, but they cannot give you legal advice. You can also call Mercy Hospital's Care Management Services office at (207) 879-3205 and request a copy of these forms.

No one can make you sign a form or stop you from signing it. You also have the right to change or cancel a form at any time. If you do so, just notify your physician of this change. It is always helpful to also forward any changes to the Health Information Services department of Mercy Hospital that will retain your current wishes in your medical record. An advance directive form does not allow anyone to violate laws regarding mercy killing and euthanasia.

The advance health care directive form does not allow others to control your money or property. To appoint someone to control your money and property, you need a different form – a financial power of attorney – and you should discuss that with your lawyer.

#### Remember:

You can plan in advance for the time when you may not be able to state your health care choices. Talk with your doctor, family members, clergy and others about your wishes. Put your decisions in writing. This may save your family and others from having to make painful decisions later on.

You can use the form available for you at Mercy. The directions about how to fill it out are with the form. You can use a different form if you want. You do not need a lawyer, although you may want to speak with one. After you sign the form, put the original in a safe place and be sure to give copies to your family, your doctor, and your hospital. You will have earned their thanks and your own peace of mind.



# Maine Health Care Advance Directive Form

You may use this form now to tell your physician and others what medical care you want to receive if you become too sick in the future to tell them what you want. You may choose to fill out the whole form or any part of the form and then sign and date the form in Part 6. These are the parts:

Part 1	Fill this out if you want to choose someone to make all your health care decisions for you, either right away or if you become too sick to tell others what you want. This person is called your agent.
Part 2	Fill this out if: (1) you did not name an agent in Part 1 and now want to choose whether you want certain treatments <b>or</b> , <b>(</b> 2) you did name an agent in Part 1 and want to tell your agent your wishes about certain treatments, knowing that your agent must follow your directions.
Part 3	Fill this out if you want to give the name of your primary physician, physician assistant or nurse practitioner.
Part 4	Fill this out if you want to make decisions about donating your organs, body or tissues after your death.
Part 5	Fill this out if you want: (1) to choose someone to make all funeral and burial decisions after your death, <b>or</b> (2) to tell your family any wishes you have about funeral and burial decisions.
Part 6	You must sign and date your Advance Directive form on this page. Have two witnesses sign the form at the same time you sign it. Tell others about your decisions and give copies to your physician, other health care providers, family and hospital.
Part 7	If you do not wish to be revived by ambulance crews should your heart or breathing stop, then you <b>and</b> your physician ( <b>or</b> nurse practitioner <b>or</b> physician assistant) need to sign this Do Not Resuscitate (DNR) form.

### **Note**

You may change any part of this form except for Part 6 and Part 7. You may cross out any words, sentences, or paragraphs you do not want. You can also add your own words. If you make any changes to the form, it is best if you put your initials and the date next to each change so that everyone knows it was your decision to make the change. The form lets you choose different ways to handle your care by checking boxes or filling in blanks. You may initial each box and each blank you fill in to show that it was your decision to check the box or fill in the blank.

Before filling out this form, we suggest that you talk with your lawyer, family members, physicians, and others close to you about your wishes. If you make changes or complete a new form, be sure to let everyone know.

### Part 1 – Power of Attorney for Health Care

#### Instructions:

This part lets you choose another person to make health care decisions for you, either right away or when you are too sick to choose your own care. The person you choose is called your agent. You may also name a second and third choice to be your agent, if your first choice is not willing, reasonably available or able to make decisions for you. If you choose an agent on this form, but do not fill out any other parts of the form, your agent will be able to:

- Make all health care decisions for you, including decisions regarding tests, surgery and medication;
- Decide whether or not to have food or fluids given to you through tubes or fed into your veins through an IV;
- Decide whether or not to use treatments or machines to keep you alive or to restart your heart or breathing;
- Choose who will give you health care and where you will get it, such as hospitals, nursing homes, assisted living settings, home health, or hospice care; and
- Make any health decision he or she believes would be consistent with your values or in your best interest, even if it is not listed in the form.

#### Who can be your agent:

You can name any adult you trust to be your agent, except your agent may not be the owner, operator or employee of a nursing home or residential long-term care facility where you are receiving care, unless that person is your relative.

#### How your agent must make decisions:

If your agent does not know what you want, the agent must make decisions consistent with your personal values, if known, or based on your best interests. In Part 2, you can decide what you want in advance. If you make choices in Part 2, your agent must make decisions based on those choices.

#### Who can see your health care information:

Once your agent has the right to make health care decisions for you, your agent can look at your medical records and consent to giving your medical information to others. The state and federal privacy laws let your agent see all of your health information so that he or she can make the right decision for you.

If you wish, you may ask that a court assign your agent as your guardian, if appointment of a guardian should become necessary. ### Part 2 – Special Instructions

If you did not name an agent in Part 1, you should fill out this Part to state what you want for care if you become too sick to make your choices known.

#### <u>OR</u>

#### Instructions if you did name an agent in Part 1:

If you named an agent in Part 1, you do not have to fill out this part of the form. If you want your agent to make all of your health care decisions, DO NOT fill out this part of the form. Your agent will make decisions in your best interests, including decisions to refuse treatment. However, you may fill out this part if you want to give special directions to your agent about your wishes, such as when you are near death, in a permanent coma or no longer able to make your own decisions. You may also cross out or add words. It is best if you put your initials and date next to any changes you make so everyone knows the changes were your decision. If you complete this part, your physician and others will follow these instructions and your agent cannot make a different decision. You may also write your wishes on another piece of paper, sign it, date it, and keep it with this form.

### Part 6—Signing the Form

If you have filled out any part of this form, you must sign and date the form on this page. You must also have two other adults sign as witnesses at the same time you sign the form. Your agent cannot sign as a witness. You do not need to have a Notary Public sign your Advance Directive form to make it legal in Maine. However, if you travel or live part of the year out-of-state, it would be wise to have it signed by a Notary. Some states require this. You can find this service under Notary Public in the phone book. Most banks also have Notaries Public and will usually notarize papers for bank customers when asked. **Make sure to tell people.** Tell your family members, physicians and others close to you what you have decided. You should talk to the agent(s) you have chosen to make sure that they understand your wishes and are willing to carry them out. Give a copy of this form to your physician, to any place where you get health care, and to any agent(s) you have chosen in Part 1. Please be sure to list the people who have copies of this form on the front page.

#### Canceling or changing the form.

**Part 1:** You may end your agent's right to make decisions while you are still able to make those decisions by telling your primary physician or putting your decision in writing and attaching it to this form. If you want to name a new agent, you must put that instruction in writing and sign it in front of two witnesses who must also sign their names.

**Parts 2-7:** You may cancel any other part of this form, or change your instructions in the other parts of this form while you are still able to make those decisions. It is best to do so by (1) writing on this form, (2) writing on another piece of paper and attaching it to this form, or (3) completing a new form. Any of those written changes should be signed and dated by you.

# Part 7—Instructions to Emergency Medical Services (ambulance crews) about what to do if your heart or breathing stops.

**This section is optional.** If you do not want ambulance crews to revive you if your heart or breathing stops, you and your physician (**or** nurse practitioner **or** physician assistant) must both complete and sign this part.

#### **Instructions for Part 7:**

- If I stop breathing or my heart stops, I do not want the Emergency Medical Services (ambulance crews) to try to revive me. My physician (**or** nurse practitioner **or** physician assistant) and I have discussed this and signed the special form on the next page. I understand that this decision will not prevent me from receiving other emergency care, or comfort care from health care workers before I die.
- I understand that the form goes into effect when I have signed it **AND** it is signed by my physician (**or** nurse practitioner **or** physician assistant).
- I understand that this directive will not be followed unless my family, caretaker or I give the signed form on the next page to Emergency Medical Services (ambulance crews), and that it is solely my responsibility to make sure they see it.
- I understand that I should carry the signed form with me unless I wear health alert jewelry, such as MedicAlert, that also tells people that I do not want to be revived if my heart or breathing stops (Please call Maine Emergency Medical Services at 207-626-3860 to see if there are other Maine EMS approved health alert jewelry companies).
- I understand that if any health care provider has any doubts about what I want, they will try to restart my heart or breathing.
- I understand that I may revoke this directive at any time by destroying this form and removing any Maine EMS approved Do-Not-Resuscitate jewelry. I can also tell the ambulance crews that I have changed my mind.
- I understand that should I change my mind, it is my responsibility to tell my physician (**or** nurse practitioner **or** physician assistant) and other people who have copies of the signed form.
