Maine Shared Community Health Needs Assessment County Summary: 2015

Qualitative Stakeholder Input

A survey of 89 health professionals and community stakeholders in Piscataquis County provided insight into the most critical health issues and determinants impacting the lives of those living in the area. According to these stakeholders, the following five health issues and health factors have the most impact on Piscataquis County resulting in poor health outcomes for residents.

- Obesity
- Depression
- Drug and alcohol abuse
- Respiratory diseases
- Mental health
