# Maine Shared Community Health Needs Assessment County Summary: 2015

## Sagadahoc County

November 2015

#### **Qualitative Stakeholder Input**

A survey of 37 health professionals and community stakeholders in Sagadahoc County provided insight into the most critical health issues and determinants impacting the lives of those living in the area. According to these stakeholders, the following five health issues and health factors have the most impact on Sagadahoc County resulting in poor health outcomes for residents.

#### Top five health issues

- Obesity
- Drug and alcohol abuse
- Tobacco use
- Mental health
- Physical activity and nutrition

### Top five health factors

- Poverty
- Access to behavioral care/mental health care
- Transportation
- Health literacy
- Access to oral health
