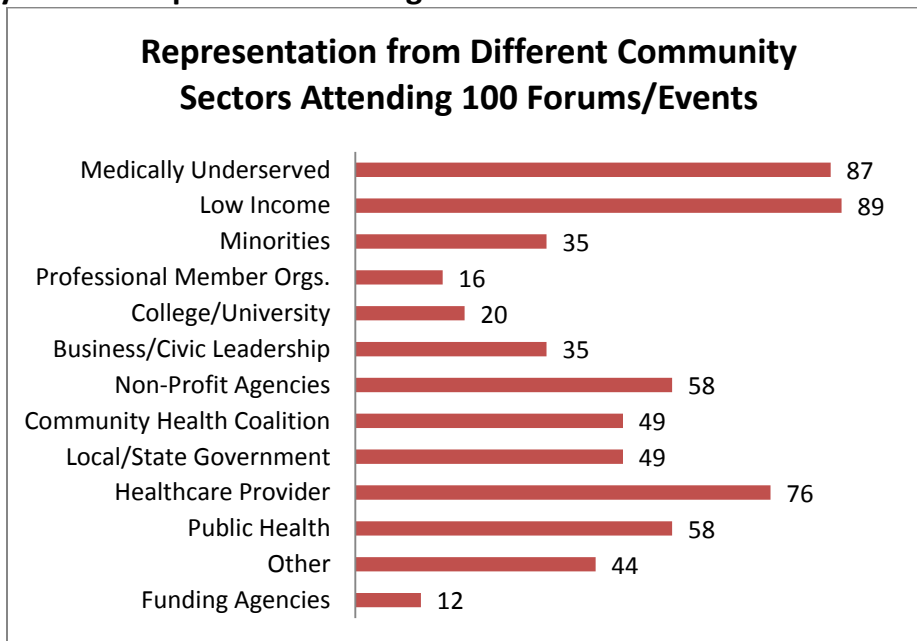

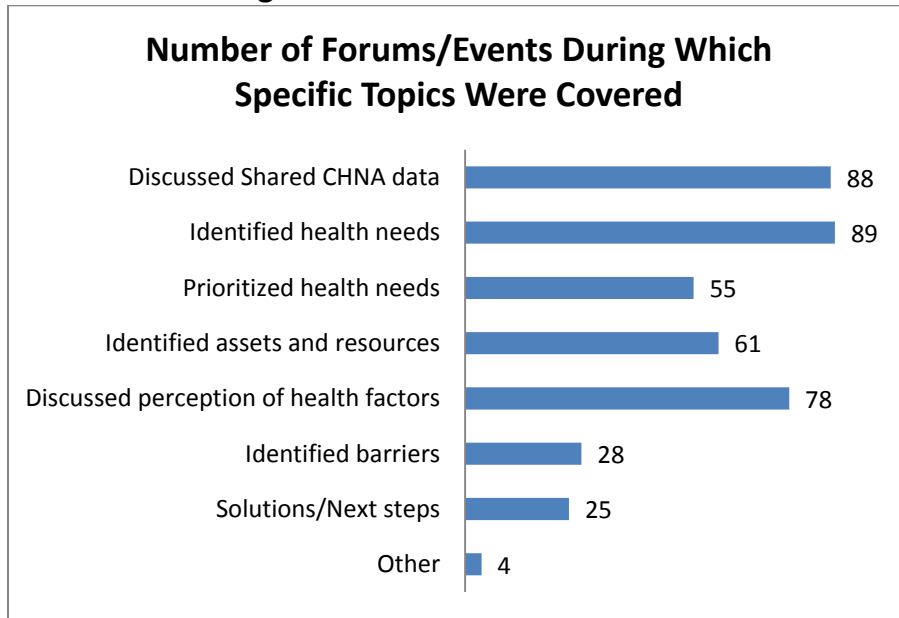
Community Sectors Represented During Forums and Events



“Medically underserved,” “low income,” and “racial/ethnic minorities” are sub-populations named specifically by the Department of Treasury/IRS regulations.

“Other” included: People with HIV/AIDS, Attorney, Seniors/Retired/Senior-serving organizations, Schools/Administrators, Clergy/Faith communities, Media, Child Protective Services, Parents (child with disabilities), Healthcare administration, Law enforcement, Youth, Wellness provider, Employment service, LBGT, People in recovery, Federal government, Farmer.

Community Forums

Forums, organized and co-led by Maine CDC District Liaisons (DLs) and SHNAPP hospital community benefit representatives, typically consisted of a prepared Power Point presentation followed by breakout sessions on health topics. In general, breakout sessions obtained input about:

- Summary statements about the issue and/or its effect on the community
- Identification of local assets and resources to address the issue
- Identification of barriers to addressing the health issue or needs of the community before more adequately addressing the issue
- Ideas for next steps, how to solve the health issue, who to include, and what the community should look like in the future

Topics of breakout sessions during forums are noted below by frequency.

- Substance Abuse (30)
- Obesity (26) & Physical Activity/Nutrition (9)
- Mental Health/Depression (18)
- Tobacco (5)
- Cardiovascular Disease (5)
- Cancer (2)
- Lyme Disease/Infectious Disease (2)
- Diabetes, Senior Health/Aging in Place, Poverty, Vision Rehabilitation, Hoarding, Food Insecurity: discussed once as a breakout session topic

Other issues identified during forums:

- Oral health/Dental care and access to services
- Environmental Health (arsenic -totally preventable, lead/kids, screening)
- Domestic Violence data seems low (under-reported?)
- Need better data on substance abuse hospital admissions
- Need better/more focus on cardiac disease; Chronic disease (hypertension, cardiovascular disease)
- Women's health as a focus issue
- Cancer prevention and support services
- Lyme disease
- Physical Disabilities; More data on people with disabilities
- Youth (middle and high school students) ; Teen Pregnancy
- Electronic cigarette use tripled in the last year (2014-2015) in the US and this emerging issue isn't captured in the data
- Aging
 - 65 + living alone; 40% Elderly need to be cared for
- Dementia and care-giving support
- Lung cancer rates are high for Penobscot County
- Pain management, chronic pain management
- Primary Care Providers (PCP) are having to do a lot of prescribing for mental health issues
- On a positive note-drinking and driving rates seem better now than "back in the day"
- Smoking
- Diabetes
- Respiratory disease
- Sexually Transmitted Diseases (STDs)
- Mental Health

Other health factors identified during forums:

- Poverty
- Transportation
- Interpersonal Violence (ACEs, domestic violence, sexual assault, bullying)
- Access to services
- Increase utilization of primary care over Emergency Department/Express Care
- Public health policy
- Affordable housing
- Mounting levels of stress
- Teaching meditation at young ages
- Health Literacy; Literacy
- People who have/or not, advanced directives and proxy for health care
- Eye care
- Employment
- Preventive services
- Access to healthy food

Community Events

Events were organized and carried out by community stakeholders (including Maine CDC DLs, SHNAPP hospital employees, or others who sat on local community engagement committees). Typically already formed groups or organizations held a presentation about the Shared CHNA data and discuss their reactions based on the group leader's questions. In general, input from events consisted of brief summary statements or questions about health issues and health factors affecting the geographic area.

Four events took place that addressed state-level Shared CHNA concerns.

Input from these events focused on either the community engagement process (what was discussed during forums/events) and what else is needed or the next steps for the SHNAPP process.

Related to the community engagement process or additional health topic concerns, groups identified:

- Input from a variety of people and sectors is important – helps us to tailor work for specific populations and local areas
- Sharing the data is important – it is an opportunity to raise awareness
- Community engagement should foster collaboration and breakdown siloes
- Incorporate community engagement input into Shared CHNA Reports
- Topics that should have more prominence include:
 - Tobacco as it is related to four of the five leading causes of death in Maine and correlates to certain cancer rates
 - Cancer
 - Elder issues (isolation, frailty, caregiving)
 - Addiction (treatment access, Suboxone access)
 - Transportation
 - Housing adequacy (due to the relationship with respiratory issues)

Discussion on state-level next steps included issues from the forums that should be considered when working on the State Health Improvement Plan (SHIP):

- Access to services is a need across topics
- ACES, resiliency and positive youth development came up in several topic areas (Should there be a bullet for "poverty" since it came up so often?)
- Focus on evidence-based practices
- Don't address issues in siloes
- Data should inform policy decisions and resource allocation

Suggestions for needed tools, resources and activities included:

- Marketing, mass communications
- Address social determinants
- Consider the “Health in All Policies” and “Culture of Health” frameworks
- Connect local efforts while supporting fine-grained interventions of specific areas and or populations
- Connect to economics and businesses

Community Engagement Debriefing Survey

During April and May 2016, an online Community Engagement Debriefing Survey was sent out to participants of the SHNAPP Community Engagement forums and events. Approximately 868 people received the survey and 204 responded. In summary:

- Input from a variety of people and sectors is important – helps us to tailor work for specific populations and local areas
- Sharing the data is important – it is an opportunity to raise awareness
- Community engagement should foster collaboration and breakdown siloes
- From the survey, participants found the community forums and events to be helpful, but did not feel this strongly
- Participants were less sure the forums would lead to future action
- Over half of those completing the survey wanted to stay engaged in the future on health improvement efforts
