# **Certified Nursing Assistant Apprenticeship Program**

#### Introduction

If you are looking for a new career in patient care, consider applying for a paid apprenticeship program to become a Certified Nursing Assistant (CNA) at Northern Light Eastern Maine Medical Center. A CNA helps patients with direct health care needs, often under the supervision of a nurse. CNAs work directly with patients and nurses, helping with the many physical and complex tasks for patient care.

## **Program Details**

- Spend 16-24 hours in class in our inhouse training program, learning hands on skills at the hospital. For the other 16-24 hours, you would be working directly with patients on our inpatient units helping them do daily life activities, observing patients who need a companion, and interacting with patients.
- Paid \$17.75/hour for all time spend in class and all time spent doing hands on work in the hospital. As well as paid time off, healthcare benefits, retirement benefits, and all other benefits available to full time

# **Nurse Externship Program**

#### Introduction

Northern Light Eastern Maine Medical Center offers a paid Student Nurse Externship program for nursing students. As a student Nurse Extern, you will be introduced to an environment that fosters excellence in all areas of nursing. 

# **Echocardiology**

#### Introduction

An echocardiology technician, also known as a cardiovascular sonographer, uses ultrasound technology to create images of the human heart and measure its performance. Echocardiology technicians work with cardiologists to diagnose and treat problems associated with the heart and peripheral blood vessels.



## **Sponsorship Details**

- Full tuition and exam costs
- Full time pay and benefits: minimum of 16 hours of work within the Echo department at Northern Light Eastern Maine Medical Center and
- 24 hours of clinical/education within the Echo department at our Medical Center
- Five-year commitment to Northern Light Eastern Maine Medical Center as Certified Cardiac Sonographer after graduation

# **Eligibility Requirements**

- Currently employed a EMMC for a minimum of one year

# **Respiratory Therapy**

#### Introduction

Respiratory therapists are specialized healthcare practitioners trained in critical care and cardio-pulmonary medicine to work therapeutically with people suffering from acute critical conditions, cardiac and pulmonary disease.

## **Sponsorship Details**

- Employees accepted into the two-year accredited program will be awarded full tuition (plus fees and books) for the Respiratory Therapy program offered through Kennebec Valley Community College (KVCC)
- During the sponsorship timeframe, Northern Light Eastern Maine Medical Center will pay for the employee to attend class, labs, and study, up to 20 hours per week.
- During the sponsorship timeframe, the employee will work 20 hours per week. Employees accepted into the program will be considered full time and will be eligible to receive full time benefits.

# **Eligibility Requirements**

- Candidates must start the admissions process through Kennebec Valley Community College (KVCC) or hold an acceptance letter for the KVCC Respiratory Therapy Program.
- Maintain a 3.0 cumulative GPA
  - At the completion of the program and certification, the employee promises to remain a Full Time Respiratory Therapist with Northern Light Health for 4 years.

## **Sponsorship Details**

- Employees accepted into the program will be awarded full tuition paid for the accelerated CST program (sponsored time);
- During the sponsored time, Northern Light Eastern Maine Medical Center will pay for the employee to attend class and study, for up to 24 hours per week.
- During the sponsored time, the employee will work at Northern Light Eastern Maine Medical Center for 16 hours per week. Employees accepted into the program will be considered full time and will be eligible to receive full time benefits.

### **Educational Loan Reimbursement**

## **Eligibility Requirements**

Employees in positions of strategic need may receive up to \$5,000 per calendar year and up to \$35,000 maximum (over 7 years) to pay toward outstanding student loan balances for qualifying programs. Eligible positions for the Educational Loan Repayment Plan may be reassessed periodically, and for the current calendar year, the positions include:

- Certified First Assists
- Certified medical Assistants
- Certified Nurse Assistants
- Certified Surgical Technicians
- Licensed Practical Nurses
- Medical Assistants
- Registered Nurses
- Respiratory Therapists
- Sonographers

- The application period is communicated via email in the spring. Completed applications must be submitted by July 1 for reimbursement in the first full pay period in November.
- Applications must be signed by an approving leader and department head or above and include a copy
  of the current outstanding educational loan balance. Applications are submitted to
  NLHTuitionReimbursment@northernlight.org, or faxed to (207) 973-7865.
- The HR Service Center will process the application and send out email notification of eligibility or of the application being incomplete (missing signatures or proof).
- Plan administrators will review all applications to determine reimbursement for the calendar year.
- Reimbursement decisions on the total amount to be paid to each eligible applicant will be communicated by the Human Resources team in late fall for reimbursement in the first full pay period in November.
- After reimbursements are received, recipient employees must submit proof of payment(s) toward their
  outstanding educational loan balance that equals the post-tax total reimbursement amount received.
   Proof of payment is submitted to <a href="mailto:NLHTuitionReimbursment@northernlight.org">NLHTuitionReimbursment@northernlight.org</a>, or faxed to (207) 973-7865.
- Proof of payment(s) toward the educational loan (even if in deferment) must be received by December 31st and must include the following:
- Must equal the post-tax reimbursement amount received by the employee, this can include regularly occurring payments throughout the year and/or lump sum payments.
- Must be within the calendar year reimbursed

### **Tuition Reimbursement**

# **Eligibility Requirements**

Northern Light Health encourages employees to pursue additional formal education in an effort to enhance knowledge, skills, and abilities, thus improving potential for future opportunities within the organization.

Northern Light Health offers an annual education benefit in the form of tuition reimbursement of a maximum of \$3,000 per eligible non-leader employee and \$5,000 per eligible Leader employee (\$1,500 and \$2,500 respectively for part-time benefits Eligible Employees). The benefit can be used for either Matriculating or Non-matriculating courses offered by an accredited institution. Reimbursement is available on course by course base, at the discretion of employee's Leader approval. Tuition reimbursement covers tuition expenses only

Employees who have been in regular full-time or regular part-time benefits eligible positions for a period of at least six months and be in good standing as an employee. Students must maintain a 2.0 GPA or higher in approved course.

- Eligible Employees may contact the HR Service Center <a href="hremmc@northernlight.org">hremmc@northernlight.org</a> to learn about tuition reimbursement and to obtain a Tuition Reimbursement Application. The necessary documents are also available on the HR Service Center Intranet Portal. One application should be submitted for each class.
  - The completed application is to be submitted to the Eligible Employee's Leader who is responsible for reviewing the request and verifying that: the course meets the requirements stated in the tuition reimbursement policy #17-132
  - Funding is available, and the employee is eligible for tuition reimbursement as defined in the policy.
- The Leader is to complete the Leader Approval section
- Thirty (30) days prior to the start of the course, the Leader or Eligible Employee is to forward a scanned or faxed copy of the completed application to the HR Service Center, using the email address: NLHTuitionReimbursement@northernlight.org for review and recordkeeping.
- The HR Service Center will send an acknowledgement to the Leader and to the employee.

# **Clinical Pastoral Education Program**

**Program Details:** This ACPE-accredited Clinical Pastoral Education (CPE) program is designed primarily for theological students, clergy, qualified laypersons, and/or those preparing for professional chaplaincy. This is a 26-week, part-time Level I – II CPE program, designed to accommodate those in a graduate academic program or working in a part-time job with flexibility in their hours. The total in-person hours required to earn ACPE credit for this unit equals 400, of which a minimum of 250 hours is spent in direct patient care, plus 50 hours in other clinical support practice and a minimum of 100 hours in educational activities. Weekly reading and writing assignments are also required.

Admission Requirements: Our training program is open to anyone interested in spiritual care. Applicants must have a high school diploma, a bachelor's degree or equivalency, and some theological education and ministry experience. Any request for exceptions to these requirements should be directed to Rev. Dr. J. Bernard Richardson, Director of Spiritual Care and ACPE Certified Educator. Applicants will be assessed by the ACPE Certified Educator, the CPE Professional Advisory Group, and other staff in an interview for their readiness for clinical learning, suitability for functioning in a spiritual care role, and capacity for serving according to the medical center and department's expectations. Pre-requisites also include: a completed CPE application form and application fee and eligibility to be a volunteer at Northern Light Eastern Maine Medical Center. Applicants must be COVID-19 vaccinated.
